(NYCC) ON REMOVAL OF THE ‘SPEED HUMPS’ IN THE
BRIDLE PATH NEIGHBOURHOOD**

ATTEND THE MEETING AT NYCC on Tuesday, January 17, 2006 at Council Chambers, North York Civic Centre, Lower Level, 5100 Yonge Street at 9.45 a.m. for the Vote on ‘Speed Humps.’
